

# NATIONAL ASSOCIATION OF TESTING AUTHORITIES AUSTRALIA

## RECOGNISED TESTING AUTHORITIES

Telecommunications equipment classified as compliance level 3 in the Australian Communications Authority's (ACA) Labelling Notice must be tested for safety, network integrity and emergency access dialling by a Recognised Testing Authority (see <http://www.aca.gov.au> for the current notice).

The ACA has determined the National Association of Testing Authorities, Australia (NATA) as an accreditation body as per Section 409(1) of the Telecommunications Act 1997 (Cth). NATA's role is to determine Recognised Testing Authorities (RTAs) as per section 409(2) of the Act.

Laboratories are determined on the basis of their accreditation by:

- NATA;
- an accreditation body with whom NATA holds a Mutual Recognition Agreement (MRA).

Determinations are made specifically for ACA Technical Standards and for AS 3260 (which is called up by TS 001). Hence, to be determined, a laboratory must have one or more of these standards identified in its scope of accreditation.

Telecommunications equipment must also satisfy the Australian EMC Framework. This requires a test report against AS/NZS 3548 (CISPR 22) from an accredited laboratory. It should be noted, however, that there is no requirement for such laboratories to be determined as RTAs.

## RTA LIST

In some instances, laboratories have exclusions listed in the scope of accreditation. These are tests which the laboratory cannot perform as part of their accreditation and hence, for which their RTA status does not apply. The exact nature of these exclusions should be checked with the laboratory.

It is also recommended that an endorsed test report (one containing the logo of the accreditation body and some reference to the accreditation) be specified in the purchase order. The endorsement will assist ACA auditors in identifying that the testing has been performed under the laboratory's scope of accreditation.
